# Pine County CSAH 43

- ▶ **Location:** Pine County CSAH 43 from Two Sons Road to TH 23
- ▶ **Project Description:** Reclaim 7.66 miles of CSAH 43 and add 3 inch bituminous overlay to bring up to 10-tons.
- ▶ **Federal Request:** \$1,000,000
- ▶ **Match:** \$750,000
- ▶ **Total Cost:** \$1,750,000

# St. Louis County

- ▶ **Location:** St. Louis County CSAH 7 Albion and Meadowlands Township between west junction of CSAH 47 and CSAH 133.
- ▶ **Project Description:** Culvert replacements and full depth reclamation of 7.2 miles of CSAH 7.
- ▶ **Federal Request:** \$2,300,000
- ▶ **Match:** \$575,000
- ▶ **Total:** \$2,875,000

# City of Duluth

- ▶ **Location:** MSAS 178 (Decker Road) from Piedmont Avenue to Mall Drive.
- ▶ **Project Description:** Mill and overlay of 1.4 miles of Decker Road and storm water system repairs.
- ▶ **Federal Request:** \$900,000
- ▶ **Match:** \$500,000
- ▶ **Total:** \$1,400,000

# Arrowhead Transit

- ▶ **Project Description:** Replace nine class five busses.
- ▶ **Federal Request:** \$1,022,400
- ▶ **Match:** \$255,600
- ▶ **Total:** \$1,278,000
